CARDIOVASCULAR RESEARCH AND ARTHRITIS EQUIPMENT EXPANDED THANKS TO NEARLY \$1.3M FROM DONORS



Last week, the Foundation awarded nearly \$1.3 million in grants to advance cardiology research and purchase equipment for arthritis research and treatment. The one-time grantmaking is an initiative called "Heart and Soul," which distributed dollars from restricted funds that were established at the Foundation with specific donor intent.

The Foundation fulfilled the original intentions that the donors used in establishing the funds and aligned them with cutting-edge research and care being offered at the following facilities: Center for Women's Health Research, Children's Hospital Colorado, Denver Health, Kavod Senior Life, National Jewish Health, and University of Colorado, Anschutz Medical Campus. <u>Read more.</u>
