# Equitable Economic Opportunity and Community Wealth Building

#### Overview

Rose Community Foundation is pleased to announce an open funding opportunity for nonprofit organizations and government agencies in the Greater Denver region. This opportunity is intended to support the work of organizations working to close gaps in access and opportunity by increasing financial freedom, dismantling generational cycles of poverty, and growing assets for individuals and communities furthest from opportunity.

Racial and generational wealth gaps have persisted across time and continue to compound poverty for people furthest from opportunity. For purposes of this RFP, we seek to fund organizations supporting individuals who identify as Black, Indigenous, and People of Color (BIPOC), individuals who have been justice-involved (often referred to as "second chance"), individuals who live with disability, immigrants and refugees, individuals living on low incomes (200 percent of Federal Poverty Level (FPL), and/or women. The implications of generational poverty are wide-ranging and self-perpetuating. The pandemic has worsened and widened opportunity gaps, but also gives us a window to think about and enact transformational change to create economic opportunity. Building wealth is a key to moving people from surviving to thriving – it builds financial sustainability for families and individuals, protects against crisis situations, and drives agency, allowing people more opportunity to make decisions in the best interests of themselves, their families and their communities.

While we understand community wealth building strategies are multi-faceted, for this RFP we specifically seek to increase social and financial capital, preserve and expand quality local jobs, increase cooperative models, support equitable provision of public services, ensure local economic stability, enhance workforce development and improve housing affordability. Other important drivers of economic opportunity and wealth building such as land trusts, food security, transportation and health care are not a focus of this RFP.

## Eligibility

- This opportunity is open to nonprofit organizations, government agencies or fiscally sponsored projects in the seven-county Greater Denver region: Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas and Jefferson counties.
- Organizations with a Civic Engagement Through Arts & Culture, Nonpartisan Voter Participation & Engagement grant or who are funded through donor-advised funds, Rose Youth Foundation, Roots & Branches Foundation or other giving circles at Rose Community Foundation are eligible for this opportunity, as long as other eligibility requirements are met.
- Organizations that house endowments at Rose Community Foundation are eligible to apply but, like everyone else, are not guaranteed to receive a grant.
- Organizations with a currently active grant period end date of November 1, 2022, or later **are not eligible** for this opportunity (except as listed above).



Organizations with open applications for the Social Emotional Learning or Policy and Advocacy grant cycles are eligible to apply but will only be able to receive funding for one application.

### **Purpose**

To support the work of organizations that increase financial freedom, dismantle generational cycles of poverty, and increase assets for individuals and communities furthest from opportunity.

# Who and where do we want to impact?

We are interested in hearing from applicants serving populations encountering barriers to economic opportunity, be they related to racial, gender or situational inequities. We recognize that intersectionality of identities may often compound the barriers to opportunity that individuals face, and we welcome applications from organizations serving multiple or overlapping priority population areas. We are especially interested in supporting organizations that serve populations/individuals earning less than 200 percent of the FPL and working on multiple strategies as defined in this RFP.

Although we fund in the seven-county Greater Denver region, priority will be given to applications focused on Adams, Arapahoe and Denver counties, or specific neighborhoods in Boulder, Broomfield, Douglas and Jefferson counties with demonstrated need established through data.

## We are interested in seeing proposals that:

- Increase social and financial capital.
  - o Support community development efforts at neighborhood, local or regional levels. We define community development as planned efforts to build assets that increase the capacity of residents to improve their quality of life. These assets may include several forms of community capital: physical, human, social, financial, environmental, political, and cultural<sup>1</sup>.
  - Increase access to capital for individuals, communities, entrepreneurs and local businesses through mechanisms such as grants and loans, including Community Development Financial Institutions (CDFIs) and other alternative financing organizations.
  - Scale peer-to-peer programs where people with lived experience are paid to support others experiencing the same or similar challenges.
- Preserve and expand local quality jobs.
  - Enhance small and family businesses within our priority populations and create opportunities for new businesses, including entrepreneurial support and business creation.
- Increase cooperative models and social enterprises.
  - o Support or mobilize values-driven local businesses with a focus on worker and community benefit.
  - o Support nonprofits in establishing or maintaining social enterprises that hire from constituents served.
  - o Mobilize informal networks and mutual aid societies that support networked job and career opportunities.

- Support equitable provision of public services.
  - O Support organizations that provide person-centered benefits counseling so that individuals do not face the "cliff effect" for needed support as income and wealth increase.
  - o Improve, build and protect equitable safety-net services that intersect and support wealth building strategies through programs or advocacy.
- Advance local economic stability.
  - o Support and mobilize community development efforts at the neighborhood level.
  - o Minimize gentrification and displacement.
  - o Increase civic participation and leadership opportunities within neighborhoods.
- Enhance workforce development, training and job placement for people making up to 200 percent of FPL with a focus on those furthest from opportunity, as defined in this RFP.
- Increase housing affordability for individuals and families that are cost burdened.
  - o Support eviction prevention programs and advocacy.
  - o Support affordable home ownership programs and advocacy.
  - o Ensure rental or home-purchase benefits counseling and navigation programs are available to meet immediate and long-term needs.
  - o Support promising practices and opportunities such as the creation of auxiliary dwelling units and older home maintenance to create and maintain wealth in families.
  - o Build policy and organize advocacy to implement strategies that advance inclusionary zoning, subsidized and affordable housing opportunities.

We recognize the important role that larger anchor institutions such as universities, hospitals and cultural institutions can play in local economies. Grants for these organizations will be considered on a limited basis, but applicants should have a conversation with Rose Community Foundation staff before applying.

## What else do we consider when making funding decisions?

- Commitment to advancing equity across gender, race, sexual orientation, income, disability and geography.
- Executive leadership, board and staff are representative of communities impacted by the issue the organization aims to impact.
- Organization or project includes diverse perspectives and experiences, and impacted communities are engaged in leadership, design and implementation.
- Financial picture of the organization.

# How much funding and what type of funding is available?

Total funding available: \$2 million. We anticipate making between 30-40 grants.

**Grant duration**: One year

#### Types of support:

- General Operating Support for organizations where the majority of their work drives economic opportunity and community wealth building work.
- Program or Project Support for organizations where the majority of their work does not have a primary focus on economic opportunity or community wealth building work.

Funding amounts will be determined based on the organization's operating budget and the breadth and depth of impact and will be on average between \$25,000 and \$75,000. We seek to fund organizations across the spectrum of operating/program budgets. Collaborative projects are encouraged to apply.

## What are the grantee reporting expectations?

Organizations receiving grant funds will be asked to submit a short narrative report of final progress and financial reporting on grant funds in the Rose Community Foundation <u>online grants portal</u> within 30 days of the end of the grant period.

December 16, 2022	All applicant organizations will be notified of funding decisions.
