

## 2023 Newcomers Fund

### Overview

Supporting the newcomers who are arriving in Colorado. Between the beginning of December 2022 and the middle of January 2023, over 4,300 people have arrived in Denver fleeing unrest in South and Central America. Since these individuals lack status that provides eligibility for employment authorization while they await the outcome of formal immigration legal proceedings, they are currently unable to work and lack access to mainstream and traditional refugee resettlement benefits afforded to refugees and asylum seekers.

The City and County of Denver, State of Colorado, and local nonprofits are responding quickly to welcome them and provide necessary services, and other parts of Colorado are beginning to see migrant families arriving as well. In response to this international humanitarian crisis that has arrived on our local doorstep, there are immediate needs that our community can help address.

Currently, grantmaking from the Newcomers Fund will prioritize the initial triage and resource navigation needs of the incoming community. Depending on dollars raised, future funding opportunities may be available to support longer-term services and integration.

### Eligibility

- This opportunity is open to nonprofit organizations or fiscally sponsored projects in Colorado.
- Organizations effectively serving newcomers arriving from the Southern U.S. border and providing supports in one or more of the following categories:
  - Emergency shelter or transitional housing resources (post shelter but prior to when permanent housing is in place)
  - Basic needs, such as food and clothing
  - Immediate medical care
  - Workforce and employment opportunities
  - Wraparound services like translation and interpretation, transportation to local appointments, volunteer coordination, etc.
  - Short-term childcare while newcomers are receiving services above
- Collaborative projects are encouraged to apply.
- Organizations with a currently active grant from Rose Community Foundation are eligible to apply.

***Please note that we are only funding initial triage services at this time***, but as fundraising continues, we hope to have grants in the future to support nonprofits addressing longer-term needs such as those listed below.

- More permanent shelter including security deposits and rent payments
- Long-term medical and mental health services

- Family reunification beyond Colorado
- Other integration supports including disability accommodations
- Immigration legal services (orientations, consultations, preparing asylum applications / EAD documentation, defense in deportation proceedings)

## Process

A steering committee with expertise in the local response and needs will make grant recommendations to Rose Community Foundation, which will make final decisions about grants made from the Newcomers Fund. Participants include representatives from the City and County of Denver, the State of Colorado, The Denver Foundation, Latino Community Foundation of Colorado, and Mile High United Way.

Fundraising is underway for the Newcomers Fund, and we may not be able to fund all eligible applications. However, the steering committee would like to begin collecting information on which organizations are providing which services. We appreciate your understanding as we seek to support those who are welcoming newcomers to our community.

## Timeline

- **Application opens:** January 18, 2023
- **Decisions made:** Grant decisions will be made on a rolling schedule twice a month. Funding amounts will be determined based on the breadth and depth of impact in addition to the total amount available to grant.
- **Application notification:** All applicant organizations will be notified of funding decisions via email.
- **Grant period:** Six months from grant period start date.
- **Final report:** Organizations receiving grant funds will be asked to submit a short narrative report of final progress and financial reporting on grant funds in the online grants portal within 30 days of the end of the grant period.
