

Building Equitable Futures for Children and Youth

Overview

Rose Community Foundation is announcing an open funding opportunity for nonprofit organizations in the Greater Denver region. This grant cycle is intended to support organizations that provide youth- and child-focused services, center youth and family voice, and address systemic inequities to increase educational achievement and bolster post-secondary work options for youth furthest from opportunity.

A main goal of this funding is to provide children and youth with equitable access to opportunities through:

- Family-centered services¹, including culturally competent parenting supports².
- Child development and/or social and emotional competence of children.
- Positive, youth-centered development³.
- College and career readiness programs that support increasing economic and social capital for young people and their communities.
- Advocacy for systemic changes that improve outcomes and increase resources for children and youth furthest from opportunity.

Purpose

Investing in equitable futures for children and youth furthest from opportunity helps improve outcomes for young people by centering their voices, perspectives, and experiences and supporting their career and life goals.

Eligibility

- This opportunity is open to nonprofit organizations, schools/school districts, government agencies or fiscally sponsored projects in the seven-county Greater Denver region: Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas and Jefferson counties.
- Organizations funded through donor-advised funds, Rose Youth Foundation, Roots and Branches, or other giving circles at Rose Community Foundation are eligible for this opportunity, as long as other eligibility requirements are met.
- Organizations with a currently active **grant period end date of 12/31/2023 or later** are not eligible for this opportunity (except as listed above).
- Organizations that house endowments at Rose Community Foundation are eligible to apply but are not guaranteed to receive a grant.
- Organizations with current funding from the 2022 Equitable Social Emotional Learning in Education or Policy and Advocacy Ecosystem grant cycles **are eligible** to apply but will only be eligible to receive funding from [one cycle in 2023](#). If you have a current grant, please speak to [a staff member before applying](#) to determine the best approach for your organization.

¹ Family-centered programs are based upon the belief that the best place for children to grow up is in a family and the most effective way to ensure children's safety, permanency, and well-being is to provide services that engage, involve, strengthen, and support families.

² [Culturally competent youth development workers](#) are aware and respectful of the values, beliefs, traditions, customs, and parenting styles of the audience being served.

³ [Positive Youth Development \(PYD\) programs](#) aim to develop and enhance positive characteristics of individuals and their surrounding context by increasing protective factors rather than focusing on risk behaviors.

Who and where do we want to impact?

For purposes of this RFP, we seek to fund organizations that support children, youth and their families with a demonstrated capacity and deep focus on:

- BIPOC individuals
- First-generation high school and college graduates
- Immigrants and refugees
- Individuals/families with low incomes
- Juvenile justice-involved individuals and children of justice-involved adults
- LGBTQ+ individuals
- Opportunity Youth (young people not in school and not in the workforce)
- People with disabilities and neurodiverse individuals
- Pregnant and/or parenting youth
- Youth in or aging out of foster care

Although Rose Community Foundation funds in the seven-county Greater Denver region, priority will be given to applications focused on Adams, Arapahoe and Denver counties, or specific neighborhoods in Boulder, Broomfield, Douglas and Jefferson counties with demonstrated need established through data.

We are interested in seeing proposals that:

- Offer programs for children and youth in and out of school. We are specifically interested in supporting programs that operate 10 hours or more per week through the school year and provide organized, structured, and supervised activities at no- or low-cost to participants. Competitive proposals will offer programming focused on emotional and mental wellness, including social emotional learning.
- Provide mental health and trauma-informed supports for educators serving children and youth.
- Strengthen wraparound parent and caregiver supports including navigation and co-located programs that address childcare, mental health and housing stability using holistic models and multi-generational approaches.
- Integrate or co-locate mental health and wellness services in schools or community-based settings where youth feel safe, supported, and affirmed.
- Promote a sense of belonging and safety in communities, housing, schools, and workplaces.
- Increase supports for critical transitions from education-to-career pathways, including post-secondary options, like concurrent enrollment programs, apprenticeship, internships and work-based options, including college access and completion programs.
- Support programs that create a strong, inclusive, and equitable pipeline of employers for youth.
- Leverage policy and advocacy efforts that that improve outcomes and increase resources for children and youth furthest from opportunity.
- Priority will be given to programming designed for and with youth and families who experience systemic obstacles and injustice at the intersections of the priority populations as outlined above.

Belonging is the emotional outcome when an individual understands that their authentic self is welcomed and celebrated and perceives a strong bond with others. A sense of belonging in the community encompasses feelings of security, support, acceptance, and inclusion.

Though there are other important drivers of equitable futures for children and youth, such as food- or nutrition-specific programs, sports programs, transportation, physical health (outside of the behavioral and mental health sphere) and standalone scholarship programs⁴ they are not a focus of this RFP.

What else do we consider when making funding decisions?

- Collaborative approaches
- Commitment to advancing equity across gender, gender identity, race, sexual orientation, income, intellectual and physical ability, and geography
- Diverse perspectives and experiences, in program leadership, design and implementation and community engagement and participation that informs the organization's work
- Executive leadership, board and staff are representative of communities the organization serves
- Financial stability of the organization
- Opportunities to leverage federal, state, and local funding or other philanthropic resources

How much and what type of funding is available?

- **Total funding available:** Approximately \$1.5 million. We anticipate making between 20-30 grants.
- **Grant duration:** One year
- **Types of support:**
 - General Operating Support – for organizations where most of their work connects to the purpose of this RFP
 - Program or Project Support – for projects or work within organizations where a substantial amount of their work does not connect to the purpose of this RFP or where the organization prefers the grant be program- or project-specific
- **Funding amounts:** Grants will range from \$25,000 - \$75,000, on average.
 - Approved amounts will be determined based on the size of the organization, the program or project budget and depth and breadth of impact. We seek to fund organizations with programs across the spectrum of budgets.
 - Collaborative projects are strongly encouraged to apply; please use the funding amount range listed for the overall program or project budget.
 - Please note that not all grant requests will be funded and those that are may not all be funding at the full amount requested.

What are the grantee reporting expectations?

Organizations receiving grant funds will be asked to submit a short narrative report of final progress and financial reporting on grant funds in the online grants portal within 30 days of the end of the grant period.

Timeline

- **February 6, 2023:** Application opens. Questions are included at the end of this document. [Office hours are available](#) for applicants.
- **March 1, 2023:** Application deadline.
- **March 2 – April 5, 2023:** Review period. Organizations may be contacted for additional information or site visits. Site visits will take place March 20 – 31.
- **May 26, 2023:** All organizations will be notified of funding decisions via email.
- **June 1, 2023 – May 31, 2024:** Grant period for funded projects.
- **June 30, 2024:** Final report is due.

⁴ Scholarship programs without evidence-based, wrap around supports such as academic support for high school graduation, college prep, high school to college/career transition, financial literacy, career readiness, etc.
