Create Your Philanthropic Legacy

Our Philanthropic Services team works with individuals and families to create meaningful legacy gifts—through wills, trusts, retirement plans, donor-advised funds and more—that can be directed toward Rose Community Foundation and other nonprofits and causes close to your heart.

Gifts Through Your Will or Trust

Leave a specific dollar amount, asset, percentage, or remainder of your estate. Your attorney can add this to your will with a simple codicil.

Retirement Plan Assets

Designate Rose Community Foundation as a beneficiary on your plan form. Retirement assets are among the most heavily taxed when passed to heirs, making this a tax-wise option for legacy giving.

Life Insurance

Designate the Foundation as the owner and beneficiary of a new or existing policy. Premium payments may be tax deductible. You can also name the Foundation as a beneficiary without transferring ownership.

Appreciated Assets (stocks, real estate, business interests, cryptocurrency) By gifting appreciated assets held for more than one year, you may be able to avoid capital gains tax and receive a charitable deduction.

Unrestricted Bequest

Donor-Advised Fund (DAF)

Create a flexible-giving account for yourself, your family or other group with maximum tax benefits. A savvy alternative to a private foundation, you and your successors can recommend grants to nonprofits of your choice, with the guidance of our philanthropic advisors.

Designated or Field-of-Interest Fund

Support a specific nonprofit or focus area with a one-time bequest or fund long into the future. We ensure your charitable vision is honored and sustained.
