

# 2026 Jewish Life Grant Request for Proposals | Cycle One

## Overview

Rose Community Foundation's Jewish Life program area seeks to support organizations and programs that strengthen the vibrancy, sustainability, safety and security of a joy-filled local Jewish community. For more on the Foundation's holistic Jewish community support, please [visit our website](#).

## Priority Funding Areas

Organizations funded under this opportunity should reflect at least one of the following priorities:

- **Support for Jewish organizations to be sustainable and impactful with the resources and capacity to best serve the Jewish community.** Applications in this category should advance major organizational goals that bolster the core functions and long-term viability of Jewish institutions. Eligible projects may include capacity-building initiatives, strategic planning, professional development, new systems (CRM, software, etc.), and other strategic organizational investments. Grants may support general operating or program expenses and should help organizations meet evolving community needs and remain impactful and connected within the broader Jewish ecosystem. - **Programs and projects that provide diverse, relevant and joyful ways for community members to connect with their identity and engage in Jewish life.** Applications should offer relevant and inclusive opportunities for Jewish engagement, reflecting the diversity of Jewish individuals and families. While each particular program may not be as relevant for each possible demographic group, we aspire to have a Jewish Life grantmaking portfolio that invests in the full age, geographic, denominational and demographic diversity of our seven-county Jewish community including interfaith families, Jews of Color, LGBTQ+, economically vulnerable, etc. Projects should be informed by data demonstrating community need and fill gaps in the local Jewish ecosystem, rather than duplicating existing efforts. Grants may support general operating or program expenses, with a focus on initiatives that build belonging and connectivity in a welcoming and vibrant environment for Jewish community members of all backgrounds.
- **Efforts to ensure the safety, security, and resilience of the local Jewish community and its institutions.** Applications should focus on programmatic or policy responses to antisemitism and Jewish harm/exclusion or work that ensures Jewish community members feel safe in their Jewish identity and Jewish institutions. Projects may include initiatives that build safe spaces for dialogue and education, foster alliances with non-Jewish community members, and/or bridge divides within the Jewish community. Grants should demonstrate measurable impact on the safety and well-being of Jewish individuals and institutions and support proactive strategies to prevent and respond to threats. *Please note that modest request for security training and infrastructure needs will be considered for applicants who can demonstrate that they have pursued training and site assessments through the [Colorado Jewish Regional Safety and Security Initiative, also known as the Secure Community Network \(SCN\)](#), which Rose community Foundation funds at JEWISHcolorado.*

## Desired Outcomes and Evaluation

By making grants within the priorities stated above, the Foundation seeks to help Greater Denver's Jewish organizations advance the following seven outcomes:

**Organizational Sustainability:** Metro Denver/Boulder Jewish communal organizations are strong, safe, and sustainable.

**Diversity:** Metro Denver/Boulder Jewish organizations reach and serve Jewish audiences that represent the full spectrum of Jewish life, including demographic, geographic, and denominational diversity.

**Inclusion:** Metro Denver/Boulder Jewish individuals and families of all stripes feel welcomed and included in Jewish programs and organizations.

**Communal Connections:** Jewish individuals and families feel a strong sense of connection to one or more parts of the Metro Denver/Boulder Jewish community.

**Engagement:** Metro Denver/Boulder Jewish individuals and families repeatedly participate in Jewish engagement opportunities that are meaningful and relevant to them.

**Social & Economic Justice:** Metro Denver/Boulder Jewish individuals and families participate in activities that address social and economic justice as an expression of their Jewish identity.

**Basic Needs:** Basic needs of all Metro Denver/Boulder Jewish individuals and families are being met.

To better understand the needs and opportunities of Greater Denver's Jewish communities and how Rose Community Foundation can best support Jewish-serving organizations in meeting these, the Foundation has committed to monitoring community progress toward these outcomes.

Reporting requirements for grants made through this funding opportunity will include reporting on indicators relevant to these outcome statements. Information about expectations and support from the Foundation for this data collection and reporting will be shared with grant recipients when funding decisions are made.

## Eligible Applicants

Jewish organizations operating in the seven county Greater Denver region. Applicants must be a nonprofit organization, school, or other tax-exempt organization in the seven-county Greater Denver region of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas and Jefferson counties.

Unincorporated organizations, groups and initiatives may apply but must have a tax-exempt fiscal sponsor.

As previously noted, we strongly encourage new-to-us organizations to apply in Cycle 2 later in 2026 and may defer Cycle 1 applications from new-to-us organizations to Cycle 2.

## Funds Available to Grant and Grant Period

Rose Community Foundation anticipates making individual, one-time, grant awards based on alignment with the stated funding priorities and availability of funds. We expect this grant opportunity to be highly competitive, and it is possible that not all applicants will be awarded funding and/or that awards may not be for the requested amount. Grant requests should generally not exceed 15 percent of the current year's operating budget.

Grants may be structured as programmatic or general operating support. **Funds cannot be used for endowments, cash reserves, debt repayment, or pass-through grants.** The majority of awarded grants will be for a period of 12 months, and organizations are eligible to apply for funds only once in a 12-month period. In limited instances, multi-year grants may be awarded based on staff, committee and board discretion. Priority will be given to organizations that have demonstrated community need and interest in a proposed project, and where multi-year support would help to advance or achieve outcomes which may otherwise not be possible.

First-time or newer grantees are unlikely to receive multi-year grants.

## Timeline

- **February 4, 2026:** Application open. Office hours available for applicants.
- **March 4, 2026, at 5 p.m. MT:** Application deadline.
- **March 5 - April 30, 2026:** Follow ups for additional information, as needed.
- **May 2026:** All applicants will be notified of funding decisions.
- **June 2026:** Grantees required to attend one of two evaluation strategy meetings. Additional meeting details will be emailed.
- **May 1, 2026 - April 30, 2027:** Grant period for funded projects.
- **May 31, 2027:** Final report due in online grants portal.

Applications are to be submitted through the [online grants portal](#) no later than Wednesday, March 4, 2026, at 5 p.m. MDT. Since Rose Community Foundation staff anticipate a large volume of applications, email communication is preferred.
