### **Gov. Polis signs new coalition-backed law maintaining science-based vaccine guidance**

DENVER, Colo. March 30, 2026 — Colorado [Gov. Jared Polis on Friday, March 27, 2026, signed a new vaccine access bill into law](#) that allows the state to rely on science-based recommendations from trusted medical experts.

Colorado Senate Bill 32, the Promoting Immunization Access for Coloradans Act, was sponsored by Sens. Lindsey Daugherty and Kyle Mullica and Reps. Lisa Feret and Kyle Brown. They introduced it to promote clarity on vaccine facts and recommendations and increase access statewide.

“We’re grateful that the Colorado Legislature approved this bill by wide margins, and Gov. Polis has now signed it into law. It’s an example of how Colorado leadership can fill the vacuum left by federal health officials. With Colorado recently experiencing a measles outbreak, [largely infecting unvaccinated children and teens](#), we see the urgent threat of low vaccine rates,” said Immunize Colorado Executive Director Susan Lontine, who is with the Colorado Chooses Vaccines coalition ([CoChoosesVaccines.org](http://CoChoosesVaccines.org)). “This law will provide more clarity to guide all Coloradans, including providers who administer vaccines.”

For decades, Colorado law relied heavily on federal vaccine recommendations to guide coverage, purchasing, and outreach. But recent shifts in federal vaccine guidance created confusion for families about which immunizations they should receive.

Likewise, health care professionals who administer vaccines have faced growing uncertainty about what guidance to follow, how to counsel patients, and how to maintain consistent access to safe, evidence-based vaccines.

The new law allows Colorado to continue to rely on trusted evidence-based guidelines from national health professional organizations: the American Academy of Pediatrics, the American Academy of Family Physicians, the American College of Physicians, and the American College of Obstetricians and Gynecologists.

It allows the Departments of Public Health & Environment and Health Care Policy & Financing to rely on these established science-based guidelines for purchasing and recommending vaccines, conducting outreach, and hosting community vaccine events. The law also ensures that the Board of Health can develop and issue clear adult vaccine recommendations to guide providers, improve access, and support consistent

public health messaging across the state. Additionally, it confirms pharmacists' authority to prescribe and administer vaccines.
